



Apparently it is OK for Deborah to break into jades house take all of Ava toys and clothes. It's OK to take your time get a missing child report finalized. It's OK for Deborah to alienate Ava from her mother - her life line.

Why would you think I haven't talked to the lawyer? Elzibeth and I have talked to the lawyer. He is afraid of the judge. I asked him to appeal. I asked him to try get a different judge since this is the same judge I was in front of with Jade when she was 15. Jades Dad filed a emergency paperwork saying Jade wasn't going to school. John threatened me at that time saying if I didn't stop with the child support he was going to make my life living hell in Arkansas. Judge King gave Jade to John at that court hearing and John drove from court to the police station in Walnut Ridge told the police he wasn't going to be responsible for her and my daughter was taken to D.C.F. Judge King kept Jade in D.C.F. and was in motion to have her put in foster care however his mother died and judge king was replaced with another judge whom found it insane that Jade was even in D.C.F and facing foster care. He released Jade immediately to me. Jade was in D.C.F for 6 months.

I explained to the lawyer this is the same judge that my ex-husband stood in front for child support and changed an order already in place from Florida.

I am forwarding non stamped or signed documents Jade received this past Monday.

I am now in process of writing to Governor of Arkansas. Attorney General. Reporting and requesting an investigation on the Judge and both lawyers and anyone else that can hopefully help shed light on how and why was it so easy for Deborah to legally kidnap Ava. Why isn't anyone concerned about the child abuse the Judicial and Deborah has blatantly allowed Ava to suffer?





I just want to point out whats even more disturbing is Taylor Hoeft filed for paternity rights in Florida on 3-12-14 | 8-23-16 against Jade Cook and Matt Wood the fact that Florida courts dismissed his case for paternity leaving Taylor Hoeft with no paternity rights over Ava.

Also Jade and Ava aren't even Arkansas residents. It takes 6 months to become resident in Arkansas. They just moved there in June 2016 so Jade could finish college in fall. I am just so beside myself. Ava needs to come home.

I can't sleep at nights. I can only imagine how my little sugarbear feels.

I just can't believe how easily she manipulated Arkansas into doing what she wanted. Friday afternoon she gets a lawyer 8-5-16 and Monday morning

8-8-16 she has Guardianship of Ava.

Her check for bond on guardianship for Ava and check to her lawyer had not even been deposited nor cleared. Court hands Ava over to Deborah before finances are even deposited and verified? I find that really strange!?!

Taylor Hoeft and Debroah Hoeft tried this in Florida and hence after 2 years in court - Florida courts asked probed due diligence and no rights were given to them.

Jade told Taylor from the get go when she was pregnant that it could be him or Matt could be possible father. Taylor and his mother Deborah both told her to go have an abortion. They didn't want anything to do with the baby

Matt Wood father on birth certificate in Florida where Ava was born told her that regardless of whether he was or not the father he would love the baby just as if he/she was his. How do think Matt got on certificate? Taylor had no care to be father nor does he now. His mother pushes him to do so since she pays for his car, cell and sends him money. He's a puppet on her strings.

I feel so bad for Ava and what she is going through. Abandonment she must be feeling. Having to call Deborah mommy is sickening! Not being able to talk to her mother - me or my mom daddy Matt all of us who raised her! Imagine she is wandering where her family is.

Ava has never been around her boyfriend Lee till coming to Arkansas. Ava does not know Deborahs 80 year old mother that she leaves her with nor her daughter Brittany being this is 1st time meeting those people. She has been around Deborah when she was 2 years old for Christmas visit. Again Deborah had a couple days with Ava 2 years ago when she came down to meet with lawyer for getting Florida try to recognize paternity rights for her son. That's when I met her. I've only met her once in the last 6 years.

Then this last visit in Arkansas is when Ava visited with her. First day of kindergarten has been taken from mommy daughter. So much mental anguish abuse by Deborah!

I feel and know Arkansas can revoke quardianship and allow us to get Ava immediately. Investigation request for both layers in Arkansas need to be filed as well as for the Judge. Governor- Attorney General of Arkansas need to be notified. Arkansas Supreme Court as well as our United States Supreme court. Arkansas aided in the kidnapping of Ava. Can you talk to the Governor? I know he has grand kids and he has power to make this right. I know he would care about this delicate matter. If a Governor can pardon death row can't they get kidnapped kids?

I cant imagine what Deborah hoeft and Taylor Hoeft did was legal. I always thought perjury was illegal. Isn't that a felony in Arkansas? Kidnapping?
