

### **PETITION FOR CHANGE OF NAME**

Comes the petitioners, Deborah Hoeft and Taylor Hoeft, and for their petition states the following facts:

- 1. This court has jurisdiction of the subject matter pursuant to statute and venue properly lies in Randolph County.
- Jade Cook is the biological mother of the child, of the minor child, Avani Gaia
   Wood, born December 29, 2010. Jade Cook is currently incarcerated in Clay
   County, Texas.
- 3. Taylor Hoeft was adjudicated as the biological father of the child in an Order Establishing Paternity filed in the records of Randolph County Arkansas at PR-2016-111 on November 22, 2016.
- 4. Deborah Hoeft is the child's grandmother and also her legal guardian as per the order of the Court filed in Randolph County Arkansas at PR-2016-111.
- 5. Avani Gaia Wood, born December 29, 2010, has the name Wood from Matthew Wood. Jade Cook listed him as the father on the original birth certificate. A paternity test later proved that Taylor Hoeft is the biological father. Jade Cook

- also admitted under oath in court that Taylor Hoeft is the father. The birth certificate has been changed to reflect Taylor Hoeft as the father.
- 6. It is in the best interest of child that her name be changed from Avani Gaia Wood to Avani Gaia Hoeft, so that the she will have the same name as her biological father, Taylor Hoeft, and her grandmother and legal guardian, Deborah Hoeft.

WHEREFORE, petitioners pray for an order of this Court officially changing the child's names from Avani Gaia Wood to Avani Gaia Hoeft and for such further relief as may be appropriate.
