ARRATIVE: The undersigned has probable cause to believe the above-named defendant, on the 1st day of February, 2011, at approximately 2240 a.m. p.m. Albert Lee / Turner (Zone: 14) in Orange County did: possess drug paraphernalia. Following a traffic stop on a vehicle driven by ITHEW WOOD (w/m/3-25-90) he consented to a search of his vehicle. During search a blue glass multicolored pipe was in the center console. It must be noted when opening the vehicle the odor of cannabis was present in the vehicle (smell). While speaking with WOOD, his girlfriend, JADE COOK (w/f/14-18-91) circled on scene Cook stated the pipe that was found in the vehicle was a property Cook provided a sworn statement admitting the pipe the center console was her property. Cook was given notice to appear regarding this incident. Based on my training and experience the suspected paraphernalia used for consumption of illegal narcotics, specifically marijuana is based on the smell of the item and the smell the vehicle
