Tyler,

I have prayed to God that Ava is kept safely with her mother Jade Cook. However that did not happen. I pray that you can help with this and stop this madness once and for all. Two years of Taylor and Deborah in Florida courts now she's getting Florida to relinquish rights to Arkansas and God only knows the suffering Ava will have to endure in Arkansas if she is successful. What's crazy about this is Deborah is not a resident of Arkansas nor was Jade and Ava. Jade got to Arkansas July 2016 court was in August 2016.

Ava's rights were not protected from the day one that Deborah kidnapped Ava meaning Child Abduction is the offense of wrongfully removing or wrongfully retaining, detaining or concealing a child or baby. No one took me seriously when I tried to report Ava missing meaning according to the Missing Children's Act it requires law enforcement to enter complete descriptions of missing children into NCIC, even if the abductor has not been charged with a crime. My concerns and effort to report Ava missing was grossly ignored by both Pocahontas police and Jonesboro police. Deborah's allegations were perjury she knew better.

Jade was incarcerated and not getting out that she was being transported to Texas. False information. Jade was released August 10th 2016.

That Ava had no blood relatives other than herself Taylor and Jade. False information.

That Taylor had paternal rights over Ava. False information. Debora did not have to provide any documents proving Taylor had any rights such as birth certificate - court paperwork - nothing.

Deborah knew Ava had been staying with me and my mother here in Florida until June 2016 while Jade was in college in New Mexico she failed to mention that in Arkansas court and Judge King was not hearing any of Jades side of the story. She made it sound like Jade has moved all over Gods green earth.

Deborah claimed that Jade could not financially support Ava again false information. Jade worked and was and is a great provider for Ava.

Judge Michael Murphy here in Florida did review and recognize that Deborah and Taylor were in the wrong and had no rights to do what they did. He ordered Taylor to bring back Ava immediately which took 2 months to do so. He also said no more court hearings until Taylor can prove paternal rights which can not be since Matt Wood is father on birth certificate since 12-29-2010 and we just had a court hearing to release jurisdiction of Florida to Arkansas and once again here we are with another court hearing hopefully to successfully to appeal - overturn release of Jurisdiction to Arkansas.

What was Deborah doing in Jades house while Jade was in Jail over the weekend? She didn't have Jades permission to go in her home. . Why did Deborah also think it to be ok to take everything of Ava's such as all her toys and clothes while in Jades home? That's breaking and entering. She even took Jades passport, computer, credit cards, and drivers license when she was in the house. She said she gave Jade's father passport, computer, credit cards, and drivers license but John says he never got it.

It's mind blowing as to how easily Deborah is allowed to lie and manipulate the system to legally kidnap Ava. Deborah was and has been deceptive, intimidating, this family. She has money and knows how to use the system to keep this going for some years. At the end of the day Ava suffers greatly.

This horrendous act has devastated and shocked Ava and our family to the core.

Parental alienation allowed by the Arkansas court and Deborah Hoeft is serious child abuse. Allowing a beautiful 5 year old Ava to suffer emotionally is mind blowing! I am seriously confused and concerned as to how easily Ava was given to Deborah without an ounce of ethical consideration in awarding guardianship to Deborah Hoeft. No measurement what so ever in the degree of attachment Ava has with her mother was not even considered? Nor any attachment to any other of her immediate family members. Not any effort to research, investigate or evaluate any of the allegations provided by

Deborah Hoeft. Deborah has only met Ava 3 times being in Arkansas was the 3rd. Ava had never met or been around Deborah's husband Lee.

When I was reunited with Ava after her return to us December 2016 she wouldn't let go of me. She asked me why I left her with Deborah. She cried and said she never wanted to be away from her family again. She's also asked for sleeping medicine that she said Deborah gave her to help her sleep. Ava is not her bubbly self and is in fear of being taken. She does not want to go to school. She is in fear that school officials will send her to Deborah and she is fearful that Deborah can get her at school. Ava has been seen by her doctor and Dr. does not think it best interest to be with Deborah. All of this has had a huge negative impact on Ava and no one has protected Ava from beginning of this.
